## The Role

Cape York NRM (Natural Resource Management) is seeking a dedicated and passionate Sustainable Agriculture Facilitator (SAF). The SAF will be a designated central contact point for farmers, landholders, industry, and community groups aimed at supporting climate-smart, sustainable agriculture practices across Cape York Peninsula.

The SAF is responsible for the provision of extension services to the agricultural sector to improve knowledge and uptake of climate-smart, sustainable agriculture practices including best practice natural resource management, practices that support emissions reduction and build climate resilience on-farm and to facilitate the understanding of carbon and biodiversity markets.

The position is responsible for the day to day project management of the Sustainable Agriculture Facilitator Project held by Cape York NRM.

## **About Cape York NRM**

Cape York NRM is a not-for-profit organisation and registered charity, with a mission to help people work to care for the natural environment while promoting the sustainable use of natural resources in Cape York Peninsula. The organisation is involved with partnerships across Cape York, and through these relationships, implement activities based on principles of sustainable development, capacity building, project support and development, and regional coordination and planning.

Cape York NRM is staffed by a dedicated team who work with individuals, groups and communities across Cape York Peninsula to care for Country, through activities that promote and support the organisation's mission.

## **Key Roles & Responsibilities**

## **Management Accountability**

- The SAF will facilitate partnerships and connections and will work closely with farmers, landholders, community groups, extension officers and agriculture industries to work together promoting and implementing sustainable agriculture practices within our community and help achieve sustainable agriculture outcomes. This will involve facilitating and implementing workshops, events and activities that promote sustainable farming outcomes to achieve Australian Government objectives for sustainable agriculture and natural resource management outcomes.
- Coordinate SAF project activities, timelines, and resources effectively and ensure required planning

and reporting is undertaken as per Australian Government requirements in a timely manner with the support of the team and supervisor.

- Support other Cape York NRM climate smart sustainable agriculture projects where needed.
- Provide regular reporting to the Leadership team on work completed and key activities underway.

## **Technical Responsibilities**

- Knowledge of the NRM and Agricultural sector and the application of best practice natural resource management.
- High level of computer skills particularly in relation to data collection and analysis, mapping, budgeting and reporting.
- Significant experience in project management including monitoring milestones, deliverables and budgets.
- Excellent time management skills with the ability to set and meet deadlines.

## **Partnerships and Communication**

- Build positive and mutually-beneficial working relationships with all Cape York NRM staff.
- Prepare reports and presentations to communicate findings and recommendations with the support of the Cape York NRM Team.
- Work closely with Cape York NRM communications staff to ensure quality information is provided to support communications about deliverables and achievements.
- Work closely with Cape York organisations and land managers, land trusts, Indigenous groups, Federal and State government, conservation and agricultural sector, community groups and other groups as required.

 Independently apply problem solving approaches to issues/situations, ensuring an adequate analysis of necessary and available information, and the appropriate involvement of Cape York NRM staff, partners and others.

- Excellent verbal communication and interpersonal skills to interact with the public and for working as part of a high-performing team

# **Qualifications and Experience**

- Relevant degree or equivalent qualification in Agriculture, Environmental Science or related field and considerable relevant experience.
- Considerable demonstrated project management skills and experience, including the ability to develop and work within budgets, meet deadlines, and maximise results from limited resources.
- Understanding of Agricultural and Natural Resource Management issues, processes and the role of community and business in Natural Resource Management.
- Experience working and/or living on Cape York Peninsula would be an advantage.
